- All policies purchased cover each guests trips valued between \$2,501 and \$3,000. Higher coverage's are available. You're your initial policy has been issued, contact DAN and request to purchase upgraded coverage.
- DAN Travel Insurance is underwritten by the National Union Fire Insurance Company of Pittsburgh, PA, with its principal place of business in New York, NY and is administered by AIG Travel Guard.
